Re: 3031 Shallowford Road Variance Requests (Jill Flournoy and Ciccozzi Real Estate Investments, LLC as Applicant)

Dear Mr. Mayor and Members of the City Council:

I am writing to express my support for Ms. Flournoy's variance requests concerning the property located at 3031 Shallowford Road (the "Property"). At the outset, I will acknowledge the obvious fact that my letter is somewhat self-serving because our school would benefit from the grant of Ms. Flournoy's requests because, without the variances, she will not buy the Property from us. That being said, I think it is important for you to hear the additional reasons why we sincerely believe that Ms. Flournoy's plans for the Property are in the best interests of the City.

When our school purchased the Property in 2018, we had every intention of building our permanent location on the Property. The City bent over backwards to aid our efforts and granted numerous variances to accommodate the needs of our student population. The City's graciousness will never be forgotten, and we remain eternally grateful for the City's efforts. Ultimately, however, we were unable to move forward with our construction plans due to an escalation in construction prices that began in 2018, continued into 2019 and were incredibly exasperated by Covid. The bottom line for our school was that building a new building would have ultimately required us to compromise the quality of education for our students because we would not have been able to remain competitive on our teacher's salaries due to the amount of construction debt we would have been forced to incur. Thus, we sadly could not move forward with our plans because we could not afford the costs of construction.

Since coming to that realization, we have marketed the Property for sale over the past several years. While we chose not to market the Property for a lengthy period following Covid's disruption of the commercial real estate market, we have had the Property on the market for a sufficient length of time to gain an understanding of the possible buyer pool. Other than Ms. Flournoy's company, we have only received interest from three distinct groups of buyers: 1) townhome/apartment developers; 2) self-storage companies and; 3) land speculators.

If the contract with Ms. Flournoy falls through, we will sell the Property to a buyer that falls within one of the three aforementioned categories, none of which provide any unique value add to the City. In contrast, Ms. Flournoy's proposed development, by being next door to Dynamo, would provide the City with a unique opportunity to create a Sports Hub in a pocket of the City where development has historically

proven challenging in comparison to other pockets of the City. Ms. Flournoy has also exhibited a sincere desire to provide community outreach and be a true friend to the City. Combining these two keystone elements, the approval of Ms. Flournoy's requests would create a one-of-a-kind attraction in the City, owned by a person who sincerely wants to be a community partner. Ms. Flournoy's requests present a clear win-win scenario.

In closing, it is important to note that while our school ultimately landed in southwest Gwinnett County, we are located less than five miles from Chamblee and currently serve 33 Chamblee residents. Completing the sale of the Property will enable our school to move forward with planned expansion efforts that would allow us to serve an additional 250-300 students per year. The main goal of our expansion plan is to grow our middle school population (an area of great need for all of Northern DeKalb County, including Chamblee). We anticipate that a large number of our new students will be Chamblee residents. I point this out because approval of Ms. Flournoy's request will not only result in a great development for the City but will also, albeit indirectly, benefit many Chamblee families by allowing our school to move forward with our expansion plans.

Dear City of Chamblee City Council:

As CEO of Dynamo Swim Club, I have actively been developing community through sport for over a decade. Having sports programming for people of all ages is a vital part of our resident's health and fitness. Dynamo's Chamblee location on Shallowford Road is adjacent to a piece of land coming up for your review. The lot address is 3031 Shallowford Road.

Jill Flournoy is proposing development of this land for a racquet & paddle center to develop tennis and pickleball courts. Through a conceptual design plan, she and I have agreed that a shared parking lot as well as shared use of the detention pond, located on Dynamo's property, would benefit both of our sports complexes. The design will provide our nonprofit with sorely needed additional parking spots during monthly swim meets while providing the new tennis and pickleball facility the largest footprint to lay courts.

It is important to me that the construction of a shared parking lot, entrance and egress not disturb my existing gravel parking area. Dynamo relies on that lot to be used for overflow parking and as a permeable surface to help absorb groundwater. The proposed design of having the entrance of the new racquet complex adjacent to the shared parking lot makes the most sense for safety and accessibility.

Of all the possible proposed usages for the land adjacent to Dynamo, I think the addition of another sports complex in Chamblee is an excellent fit for both Dynamo and our Chamblee community. I'm asking you to support this project to offer another venue for fitness, sport and community in the City of Chamblee.

Dear Council Members,




