**A RESOLUTION OF MAYOR AND COUNCIL OF THE CITY OF CHAMBLEE,
GEORGIA ADOPTING AN AMENDMENT TO THE FISCAL YEAR 2024 ANNUAL
OPERATING BUDGET AND PROVIDING FOR AN EFFECTIVE DATE.**
